EU MISSION TO INDIA SUSTAINABLE BUILDING MATERIALS

MUMBAI - DELHI - BANGALORE; 21-25 SEPTEMBER 2015



ABOUT THE MISSION

Piedmonte Agency for Investment, Export and Tourism (CEIP), The Indo Italian Chamber of Commerce and Industry (IICCI) and the Coventry University Enterprises Ltd. (CUE) in collaboration with the European Business and Technology Centre (EBTC) in India, will organize a business mission of European companies dedicated to "Sustainable Building Materials | Construction industry from 21-25 September 2015 in the cities of Mumbai, Delhi and Bangalore.

WHY PARTICIPATE

Indian real estate and construction industry is growing by 15.2% p/year and is estimated to reach a value of € 756.7 billion in 2028. The rapid urbanization – from present 406 to a population of 600 million in 2031- will require the construction of 50-70 million square meters of commercial and residential space every year. Urban residential demand alone is for 34.1 million units by 2022. It leads to a rapid growing demand for building materials, technologies and services, such as:

Insulation materials (Rockwool, Glasswool, Fibre Glass, market is 150.000 Mt); construction chemicals (admixtures, flooring and waterproofing agents, adhesives and sealants and repair and rehabilitation); Roofing and Enveloping; Bricks, Ceramic Tiles, Marbles and Paints; Windows, Doors and Frames; Construction Equipment, Lifting & Material handling; technology for Cement, Concrete, Mortar, and Pre Cast; Construction & Project Management software.

Green building is also growing as a relevant market segment, driven by consumer demand and by the corporate social responsibility of large developers as well as fostered by Government initiatives, such as the recently launched 100 smart cities plan and it has seen a growth from a green built up area of 1.858 sqm in 2003 to 160 million in 2015.

That is why the project also aims at laying down a set of Product Environmental Protocols (PEP) to be used as "terms of reference" for launching in India voluntary Eco Certification schemes for Building Materials based on ISO 14020 series of standards and European best practices with a focus on three families of product: Cement, Concrete and Mortar | Brick and Tiles | Waterproofing and Insulation.
