A document certifying that electrical household devices to be imported comply with applied Chilean standards. The certificate is to be obtained through one of the following procedures:

- System A is restricted to national manufacturers and does not apply to imported products.
- System B involves the certification of each lot to be imported.
- System C is a type approval procedure with subsequent monitoring of imported products.
- System D stands for a recognition procedure for conformity certification issued in the manufacturing country.

Required for market access.

Spanish name of the document = Certificado de Conformidad

The certificate is to be obtained by the importer. The competent authority is the Ministry of Economy, Superintendencia de Electricidad y Combustibles = Superintendencia de Electricidad y Combustibles (SEC), Avenida Libertador Bernardo O'Higgins 1465, CL-8370076 Santiago, phone number: +56 22 60000732. With regard to system D the recognition of foreign certification is to be applied for directly at the latter authority. In the case of certification according to system B or C the actual procedure of certification of conformity is carried out by corresponding institutions authorised by the SEC. Information regarding these institutions and their fields of activity can be obtained at the SEC. The SEC is also responsible for the determination of the scope of products subject to certification.

No specific form required.

The application is to be prepared as a letter of request in Spanish.

The processing time is two months in the case of system D and may vary for the other systems.

There is no processing fee for certification according to system D. With regard to the other systems the actual fee is fixed individually by the certification institution involved and can therefore vary.

The certification remains valid as long the products remain unchanged.

A sample of the products to be imported must be enclosed with the application letter.
